The meeting was called to order by Rodney Caines, Acting Chairman of the Board of Commissioners.

The previous minutes were approved.

The Board executed Town of North Hempstead vouchers for the various bonded projects.

Matt reported that the foundation work has begun for the office portion of the Drexel Ave AOP project. Renovations in the office are underway as well.

The Board received a request for a summer help position. The applicants' age needs to be verified.

THERE BEING NO FURTHER WATER DISTRICT BUSINESS TO DISCUSS, THE BOARD CLOSED THE WATER DISTRICT MEETING AND OPENED THE FIRE DISTRICT PORTION OF THE MEETING.

Matt reported that the gear washer has been set up and is available for use at Station 2.
