The meeting was called to order by Rodney Caines, Chairman of the Board of Commissioners.

The minutes of 10/15/25 were approved.

The Board signed 8 TONH Claim Vouchers.

Matt reported that the PFAS levels for Wells 15 & 18 have come down.

THERE BEING NO FURTHER WATER DISTRICT BUSINESS TO DISCUSS, THE BOARD CLOSED THE WATER DISTRICT MEETING AND OPENED THE FIRE DISTRICT PORTION OF THE MEETING.

Randee reported that so far only Hook & Ladder has submitted their required rig checks.

Randee reported that the grant for fire protection has been approved.

Randee reported that NFPA rules state that the chauffeur needs a pack. The District Mechanics said the back of the seats that are being removed can remain in the vehicle and the packs can be stored there.

Assistant Chief Gjonlekaj inquired as to whether Red Alert can track members' points. A quote will be obtained.

The following Chiefs items were discussed:

1. The Rescue Squad is requesting 30 Tee shirts for their active members. They will be used for stand-by and at calls. They are requesting because there are times when the weather does not require jacket. This would be an addition to aid in safety & visibility on the roadways, as the silkscreen is reflective. The cost for 30 shirts is \$1,874.70. quote attached. **Approved.**

2. The Chiefs office would like to discuss 2026 budget items as to prioritize the items previously submitted. **Set a date to look at a bus with Randee and allow Rescue Squad to participate as well.**
3. The Chiefs office would like to know if the district can inquire about the status of the tower Ladder. With regards to an updated timeline for the rig to go into production and a potential delivery date. **Randee is waiting for a response from them.**

The Chief also requested that a down payment be made for the monument. **Approved.**

The attached vouchers for the Westbury Water District totaling \$103,435.32 and the Westbury Fire District totaling \$156,719.94 were approved for payment.
